- Tensions remain high between China and India after a dispute over the border last week resulted in a deadly clash.
- The World Health Organization reported on Sunday the biggest one day increase of coronavirus with more than 183K cases in 24 hours.
- Latest figures show over 8.9M confirmed cases of the coronavirus worldwide with over 468K deaths. Concern continues to grow over the spike of new cases in the U.S. which now has over 2.2M confirmed cases with nearly 120K deaths. CT has over 45K cases and 4,260 associated deaths.

- The U.S. Commerce Department announced last Tuesday that retail sales rose 17.7% in May, the biggest month-over-month gain ever.
- The U.S. Census Bureau released housing starts data last week showing an increase of 4.3% in May 2020 month-over-month. Housing starts decreased 23.2% year-on-year.

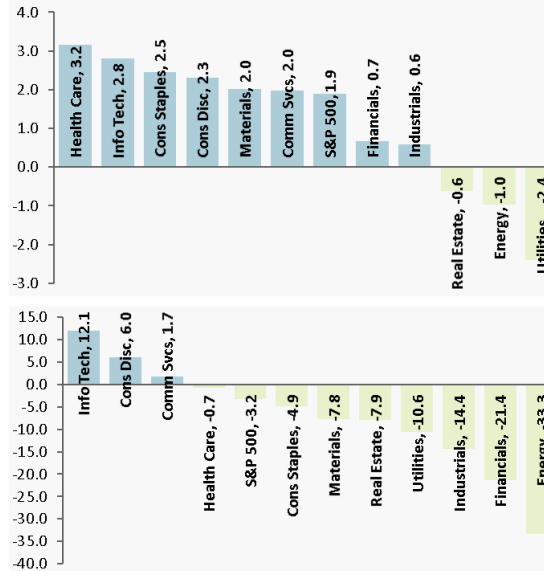

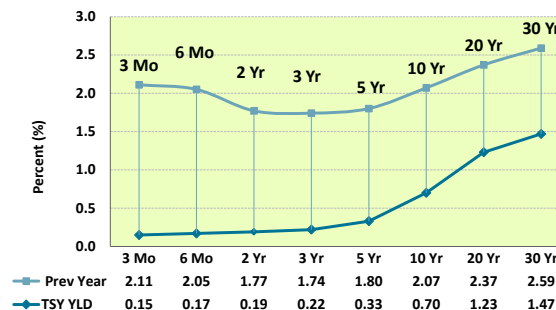
