The Pension Benefit Guaranty Corporation (PBGC) has issued guarantee limits for single-employer plans for 2020. The guarantee limits for single-employer plans that fail in 2020 will be 3.65% higher than the limits that applied for 2019, due to indexing ERISA requires.
